-  Whilst we take the utmost care and precautions to look after your pet/s at Pet Cottages it must be distinctly understood that the owners and authorized staff of Pet Cottages are in no way liable for any damage to or loss of property of any kind. Pet Cottages is not responsible for any leads, toys, bedding or collars left at the premises.
-  Pet Cottages and its authorized staff are in no way liable for death or injury through sickness, escape or from any cause whatsoever to your animal whilst it is in our kennels.
-  Should your dog show any signs of aggression it is your duty to advise us in advance so that we can prevent any altercations. Pet Cottages will not be held responsible for any accounts accrued through injury or loss should your dog/s fight with each other.
-  It must be understood that no dogs will be permitted in the kennels if valid inoculations certificates (done two weeks prior to arrival) are not produced. Namely 5 in 1 annual vaccination, rabies and kennel cough. *Please note – Kennel cough must be specifically requested from your vet.*
-  A 50% deposit is required to secure bookings at Pet Cottages. Any cancellations less than 30 days before check in date during peak season will result in loss of deposit. No dogs will be released if payment is not made in full on check out. Day of arrival and day of departure will be included in the number of accommodation days.
